May 16, 2023

Patty H. made the motion to approve the minutes as read Gavin W. seconded the motion carried.

Suggestion Box:

Check filter for drinking fountain- The filter has been replaced.

Pickel Ball plug not working-This has been repaired.

Smoking in pool area-This will be addressed later in the meeting.

Residents Comments:

Katherine Bishop:

Military discount-We use Tom Taylor's or Patty Hynes military discount, when a discount is given.

Dogs in compound- We would gladly correct this problem if we knew who the offender is. If you can inform us who the offender is, we will contact them and hopefully correct the problem.

Quarterly HOA fees-The January, February and March minutes were checked for this content, and it appeared all three months as well as being printed in the Echo.

Carport on Venetian- We have addressed and sent another letter to 34 Venetian Their response was "I'll just call my Lawyer."

Jack Gaiser:

Pool and Spa steps slippery-We are looking for something to put down without draining the pool. It was suggested that we use a suctioned bathmat. Tom W did find a product with an adhesive backing that just needs to be weighted down.

Sharon Dugan:

Bathroom door blew open during storm-The bathroom door did indeed blow open during a storm a resident was able to get the door closed and clean up the mess. It was immediately reported to Tom W, and he came to the clubhouse as soon as he could. Tom W reported that there was a vacuum when the restroom door blew open and caused the door in the clubhouse to open as well.

It was suggested that a bungie cord be used on the doors to keep them from blowing open. This cannot happen.

The doors in the clubhouse must remain unlocked during an activity or occupied in case of a fire. It is also necessary to have a key to lock the doors in the clubhouse.

The restroom doors have now been replaced.

Why was the grill not set up for the pool party- The grill is never left set up, it is up to the person using the grill to set it up and return and cover it to the original area. Also, all the gas lines are fixed and ready for use.

FDIC is not safe-The FDIC is safe it was created in 1933 after the stock market crashed. It insures 250,000.00 per signer on an account and we have three signers on our accounts.

The concrete where the gas lines were buried has been fixed.

The bathroom doors have been replaced. As a side note please turn around and make sure the door is shut. The door was not closed properly, and the wind ripped it off its hinges. In the handicapped restroom we have installed new shelves for storage.

Tom W. will contact an electrician to evaluate flag area and power area.

The pool is closed today 5/16/23 but will be fixed tomorrow 5/17/23.

Cindy added that the storage building will be delivered on 5/17/23. It was supposed to be here today, but they called to say it would be delayed.

Gavin is moving the orange fence to make sure the work area is clear when the building arrives.

The old trailer in the compound has been removed. The maximum length of items placed in the storage area is 38 feet.

The Hot Tub overflowed so the water was turned off then there were complaints that it needed water, the water was turned back on and there have not been anymore issues with the Hot Tub overflowing. The problem could be a fill float we will look into replacing the float.

New Business request by Tom W.

Estimate for spraying around the clubhouse area:

Clark 300.00 month

Bugs bee ware 125.00 month

Isaac gave a bid of 100.00 per month but we would have to supply the Round up.

We think that it is only necessary to spray about every 6 weeks. This would also save us more money.

We propose we use Bug Bee Ware as we already have a contract with them for insects. Another point is that Bug B Ware is licensed and insured and is very dependable.

A motion was made by Cindy H to spray weedkiller in the club house area.

Patty H. seconded the motion carried.

Connie C. commented on the turtles heading west and that we should be careful when driving our golf carts. She also asked that we use the road and drive into the parking lot instead of cutting through the grass.

Resident Comments:

Bob Evans:

Commented on the electrical post behind the club house that contains power meters. He stated they should be removed as he had hit them in the past. He stated he called the power company they suggested putting up a bumper. Patty H. asked him to show Tom W. specifically what he is talking about to see if anything needs to be done about them. He also commented that the floor in the clubhouse is atrocious and needs to be cleaned. Cindy explained that the floor was clean and that it is worn as it has been down 10 years or more.

Bobbie Snow:

Bobbie said she received a phone call requesting that she arrange a Cruise for Covered Bridge. The cruise is set for January 27, 2024, for 8 nights not sure of all the stops yet will get more information posted in clubhouse if interested. The cruise starts at \$1099.00 per person and that does include the bus to and from Covered Bridge. The cruise line is the Royal Caribbean, and more information will follow.
